MILITARY SCIENCE – MILITARY AFFAIRS

Attila Varga:

The author introduces the general nature of Rules of Engagement (ROE) used by NATO during its peace support operations. He details the legal and non-legal basis of the ROE, the main principles of those rules, as well as their development, approval and execution process, illustrated with statements taken from the foreign language literature. Many experiences gained from real-time operations and exercises show that wide range dissemination of knowledge on this subject has paramount importance, therefore the author supports in this study the NATO initiatives to pay more attention to the ROE training within a military environment.

József Koller:

By writing a thesis on today's rotary wing aircraft I intended to provide a better picture about the situation of attack and transport helicopters, both in Hungary and abroad. Ferenc Mező:

Pál Kádár:

The past 2 years have resulted meaningful changes in the structure of Hungarian Defence Forces (HDF). The author provided a short resume in his previous article about the structure of HDF and about the structure of the organization which is responsible for high level command and control of HDF. Current article correlates to the previous one and gives an appraisal in connection with the regulators of functioning and points out the newest results as well.

The author of the following dissertation makes an attempt considering the fundamental questions of management to summarize on the basis of the science literature and experiences those requirements and talents which the ideal leader or commander has to meet among recent circumstances.

The foundation of an institution of higher military education has long since been an all-Hungarian demand as well as a matter of public support. Though the Act 7:1808 constituted the National Military Academy as a legal entity, its formal opening and the start of officer training in Hungarian language, in defence of the interests of the Hapsburg Empire, have been counteracted by the sovereign and the Vienna War Council. This article treats the circumstances around the birth of the act together with the phases and characteristics of its formation.

Gábor Csutorás:

Fires Caused by Terrorist Attacks on Military Airports 110

The nature of fires that are results of terrorist attacks differ from traditional fires. If we accept this thesis, we also need to accept that the techniques of rescue and fire-fighting in these special cases are different as well. In my study I examine these differences and try to find solutions for the execution of rescue and fire-fighting, regarding military airports.

Stefánia Bódi:

Capital punishment, also referred to as the death penalty, is the execution of a person by the state as punishment for a crime. Supporters of capital punishment argue that it deters crime, prevents recidivism, that it is less expensive than life imprisonment and is an appropriate form of punishment for some crimes. Opponents of capital punishment argue that it has led to the execution of wrongfully convicted, that it does not deter criminals more than life imprisonment, that it is more expensive than life imprisonment, and that it violates human rights.

János Gligor:

In the field of science in Hungary there are not too many debates about the issues concerning ethic dilemmas on publishing and education. The only exception is the ethic conference, organized by the Hungarian military scientists in 2005. However earlier there were remarkable debates on this issue both in Hungary and abroad. The author in his shortened, edited version of his application of scientific techniques introduces the main statements, debates on this issue and some possibilities of further researches
