### PUBLICATION RULES

**Dear Authors,**

*Hadtudomány (Hungarian Military Science)* is a peer-reviewed, “A” category periodical of the Hungarian Association of Military Science and the Committee on Military Science of the Hungarian Academy of Sciences published in four printed and one online editions (see <http://www.mhht.eu/>).

#### **1. Basic rules of publication in the Journal**

a) *Hadtudomány (Hungarian Military Science)* only publishes papers not yet published in any other periodical, thus regarded as first publications, which fact is to be declared by the author (see Annex 1).

b) Review by two independent peers invited by the Editor in Chief must be accepted by the author(s), and the peers’ recommendations must be implemented in the paper submitted for publication. If the author(s) maintain their opinion in the issue in question, it is the Editorial Board, which makes the final decision on the publication of the paper in the Journal.

c) In addition to the peer reviews, the Editorial Board is entitled to examine the authenticity of the papers also with the use of a plagiarism detection programme.

d) The Editorial Board reserves the right to decide in which issue and section of the Journal, including its *printed* or *online* editions, the paper in question should be published.

e) On the reception of a paper its author(s) are duly informed. Unpublished papers will not be retained or returned.

g) In the relevant sections of the online or printed edition of the Journal English language papers are also published.

h) The Editor in Chief can issue a certificate of intended publication only if the two peers’ reviews are completed and they unanimously support the publication of the submitted paper. Subsequent alterations to papers submitted by the author(s) to the Editorial Board will only be accepted if those are in line with the peers’ comments (clarifications).

i) For the flawless edition and publication of our Journal, the following is to be taken into account and complied with:

The publication dates of each issue, and the deadlines of the submission of papers:

In the online edition of the Journal, the upload of peer-reviewed papers is continuous. The issue is closed on 31 January each year.

## 2.) Author guidelines

a) Paper text font size: 12-point, Times New Roman; line spacing: 1.2; paragraph: 0.8 cm.

Footnotes font size: 10-point, Times New Roman; line spacing: 1.0; with no paragraph.

b) Manuscript of the papers and the completed, signed Author's Declaration (**Annex 1**) are to be sent as an e-mail attachment in Word or RTF format, to the e-mail address of our Editorial Office ([hadtudomany@gmail.com](mailto:hadtudomany@gmail.com)).

c) The paper is to include the name(s), place of work, position, and availability (address, phone number), ORCID ID of the author(s), the title of the article, an abstract with keywords, and a list of reference. In the absence of any of these data the Board of Editors will not accept the manuscript for publication.

d) The total length of a paper should not exceed **40,000 characters**.

f) The content of an abstract of at least 300 characters and maximum 800 characters should include an outline of the scientific problem and present the main conclusions of the research.

g) There should not be more than five keywords, and the amount of references should be less than 30 elements.

h) The Board of Editors does not accept papers for publication in successive parts.

## 3.) Formal requirements for illustrations

a) If there is a need to illustrate a paper with images (photos, maps, graphs, etc.), those should be in the language of the article.

b) Within the text, the source of all illustrations (accessibility on the Internet, download date, etc.) should be indicated. If the illustrations are made by the author(s), it should also be indicated.

c) **Illustrations of papers intended for the printed issue should be in black and white**, as the printed issues of the Journal are printed in black and white.

d) The resolution of the longer side of the illustration integrated into the text should not be less than 1,500 pixels, while the resolution of the longer side of a whole-page illustration with text should be at least 2,500 pixels. **Minimum 300 DPI resolution for photos and reproductions is required.**

e) Copying an illustration from a Word file results in degradation of quality, therefore each figure should also be sent separately in its original format (jpg, tif).

#### **4.) Mandatory form of bibliographic references (Chicago, author(s)/ date format type)**

In *Hadtudomány* the so called Chicago style, i.e. author(s) / date, is the received format. References should be placed in footnotes – instead of the text – and listed in the **References** section at the end of the paper.

The reference in the footnote comprises the surname of the referenced author followed without a comma by the date with comma, and the page number with a period at the end. (The word page is not abbreviated in any way.)

E.g.: M. Szabó 2019, 28.

The data of works cited in shortened format are to be listed in the **List of references** at the end of the paper, containing the works in alphabetical order (based on the authors' last name initials), as follows:

a) For a single-author book:

M. Szabó Miklós 2019. *A Magyar Néphadsereg és a Varsói Szerződés csapatainak részvétele Csehszlovákia megszállásában*. Budapest: Dialóg Campus.

b) For a co-authored book:

de Haas, Hein, Castles, Stephen, Miller, Mark J. 2020. *The Age of Migration. International Population Movements in the Modern World*. 6th Edition. London: Red Globe Press.

c) For a book by more than three authors:

If a book is the work of four or more authors, not more than ten of them should be listed in the References. In the footnote only the first author is to be included, followed by “et al” (and others). For more than ten authors, the first seven of them are to be listed in the reference list and followed by “et al”.

d) For a book chapter:

Perjés Géza 2003. Gróf Zrínyi Miklós (1620–1664). In Király Béla, Veszprémy László (szerk.): *A magyar hadtörténelem évszázadai*. 109–122. Budapest: Atlanti Kutató és Kiadó Közalapítvány.

e) For an article:

Padányi József 2021. Az éghajlatváltozás hatásai, mint a katonai erő előtt álló biztonsági kihívások. Hadtudomány 31 (1): 31–43.

f) For Internet links:

Takács, Vivien: 50 kilogrammos mozsárbombát találtak a komáromi vár falában. [http://www.honvedelem.hu/cikk/54192\\_50\\_kilogrammos\\_mozsarbomba](http://www.honvedelem.hu/cikk/54192_50_kilogrammos_mozsarbomba) (Downloaded: 21/11/2015).

g) In case of several authors, the name of the first author of the cited work is to be taken into account.

h) The order should be based on their surname also in the case of foreign authors.

For example:

- Huntington, Samuel P. 1994. A katona és az állam. Budapest: Zrínyi Kiadó–Atlanti Kutató és Kiadó.
- Bolton, John 2020. The Room where it happened. New York: Simon & Schuster.
